Board certification demonstrates that the physician has met the requirements of a particular board for that particular specialty; this involves successfully completing a specific amount of training and passing an examination. Members of the public should keep in mind that physicians who are not board certified may be as well qualified as those who are. A Medical Doctor's board certification or recertification may or may not be included in his or her education and training information on this website. Additionally, the Board of Medical Examiners cannot verify the currency of such information, as Medical Doctors are not always required to advise the Board concerning board certification as a requirement of licensure.
